Fraud and Compliance Issues for ACOs and Integrated Health Systems

Cells as Drugs: FDA Regulation of Your Drugs Sponsored by: Medical Research, Biotechnology & Clinical Ethical Issues

A recent decision in the case US v. Regenerative Sciences, LLC by the United States District Court holding that adult stem cells are drugs has created considerable controversy as to the jurisdiction of the FDA and its impact on innovation for cell-based therapies.

Efforts are underway in some states to circumvent the ability of the FDA to regulate these sorts of activities by promoting legislation that defines the activities involved in cell-based therapies as medical practice, thereby raising issues of preemption, among others. This session will examine the Regenerative Sciences decision, the legal basis for allowing the FDA to regulate cells as drugs, whether there is a need for further regulation, and whether regulation can be accomplished within the current FDA framework. The speakers, who come from various backgrounds and points of view in this evolving debate, will explore alternative approaches that are intended to protect patients but allow innovation.

Compliance with the various PPACA provisions set to become effective in the 2013-2014 years is a hot topic for employers. PPACA could fundamentally alter the way in which employers provide health benefits to their employers and may result in significant penalties to employers who do not provide health insurance coverage. This breakout will outline employer action items required for the 2013-2014 years such as: comparative effectiveness fees; flexible spending account limits; several employer notice requirements; new contraception coverage mandates; summaries of benefits and coverage; and other requirements. The panel will discuss what the employer will be required to do for each of these provisions and what effect these provisions may have on the employer administratively and financially. Additionally, the session will cover how employers are bracing for the health care reform provisions, the employer mandate, employer penalties, and what the insurance market is anticipating or doing in preparation for the potential market changes resulting from the Exchanges.

Observation Status: Caught Between a Rock and a Hard Place?

Sponsored by: Payment & Reimbursement Interest Group

Physicians working in hospitals must decide whether to admit a patient or continue to treat him or her as an outpatient, observing the patient's status. Under Medicare's current policies, this decision, which should be guided by medical considerations, can have financial consequences. Medicare contractors are increasingly denying hospital payment for admissions that result in relatively short inpatient stays, often concluding that the patient needed observation care only. In such cases, however, Medicare rules do not allow a hospital to re-categorize the patient post-discharge as

an outpatient, and hospitals cannot re-bill for the full range of services that indisputably were provided, including observation services. On the other hand, if a physician continues to place a patient in observation status, this decision could affect whether Medicare will cover the beneficiary's subsequent skilled nursing facility care. Also, Medicare payments may not adequately cover a hospital's resources expended for "observation care."

This program will cover many legal issues raised by this problem, including:

- The Medicare coverage and payment rules regarding inpatient versus outpatient (observation) status, guidelines for inpatient admission criteria, the weight to be granted to admitting-physician decisions, and Medicare policy regarding predischarge changes to a patient's status and re-billing for outpatient services following a denial for inpatient services
- The Centers for Medicare & Medicaid Services' (CMS) Medicare Part A to Part B Rebilling demonstration
- CMS's recent solicitation and summary of stakeholder comments on this problem published in the CY 2013 Outpatient Prospective Payment System Final Rule
- A discussion of recent litigation filed by the American Hospital Association challenging CMS policy and a class action lawsuit brought by Medicare beneficiaries
- Potential solutions and whether they require subregulatory, regulatory or legislative changes
