# Speakers

**Honorable Neil P. Olack—Bankruptcy Judge, Northern and Southern Districts of Mississippi.** Neil P. Olack is the United States Bankruptcy Judge for the Northern and Southern Districts of Mississippi. Prior to taking the bench, he practiced law of 25 years in the areas of bankruptcy, creditor's rights, and workouts. While in private practice, Judge Olack served on the board of directors of the American Bankruptcy Institute and on the advisory boards of the *American Bankruptcy Institute Law Review* and the *Emory Bankruptcy Developments Journal*. He was board certified in business bankruptcy law by the American Board of Certification and was a member of its board of directors. Judge Olack has considerable experience teaching bankruptcy, both as an adjunct law professor and an instructor in a masters of business administration program. He also taught at the Graduate School of Banking at Louisiana State University. Additionally, he has been a frequent lecturer on bankruptcy issues for professional and continuing legal education programs throughout the United States. Judge Olack is a fellow of the American College of Bankruptcy. He served as the Fifth Circuit Governor for the National Conference of Bankruptcy Judges.

**Bill Rochelle**— Bill Rochelle joined the American Bankruptcy Institute in 2015 as its Editor-at-Large, writing every day on developments in consumer and reorganization law. For the prior nine years, he was the bankruptcy columnist for Bloomberg News. Bill got his undergraduate and law degrees from Columbia University, where he received Harlan Fiske Stone Scholar awards from the law school. Before turning to journalism, he practiced bankruptcy law for 35 years, including 17 years as a partner in the New York office of Fulbright & Jaworski LLP. In addition to writing, Bill travels the country for ABI, speaking to bar groups and professional organizations on hot topics in the turnaround community and trends in consumer bankruptcies.
