Keynote Speakers

Honorable Neil P. Olack—Bankruptcy Judge, Northern and Southern Districts of Mississippi. Neil P. Olack is the United States Bankruptcy Judge for the Northern and Southern Districts of Mississippi. Prior to taking the bench, he practiced law for 25 years in the areas of bankruptcy, creditor's rights, and workouts. While in private practice, Judge Olack served on the board of directors of the American Bankruptcy Institute and on the advisory boards of the *American Bankruptcy Institute Law Review* and the *Emory Bankruptcy Developments Journal*. He was board certified in business bankruptcy law by the American Board of Certification and was a member of its board of directors. Judge Olack has considerable experience teaching bankruptcy, both as an adjunct law professor and an instructor in a masters of business administration program. He also taught at the Graduate School of Banking at Louisiana State University. Additionally, he has been a frequent lecturer on bankruptcy issues for professional and continuing legal education programs throughout the United States. Judge Olack is a fellow of the American College of Bankruptcy. He served as the Fifth Circuit Governor for the National Conference of Bankruptcy Judges.

Honorable John P. Gustafson, Bankruptcy Judge for the Northern District of Ohio, Western Division. John P. Gustafson has been a bankruptcy law clerk, an associate and partner in a law firm that did both debtor and creditor representation, a solo bankruptcy practitioner representing debtors, banks and trustees, the staff attorney for a Chapter 13 trustee, a Chapter 13 Trustee, and since his appointment on April 8, 2014 a Bankruptcy Judge for the Northern District of Ohio, Western Division.

John M. Czarnetzky. John Czarnetzky has been a professor at the University of Mississippi School of Law since 1994. He has been honored as outstanding law professor several times, and was named the outstanding professor at the University of Mississippi in 2016. He teaches bankruptcy, civil procedure and commercial law.

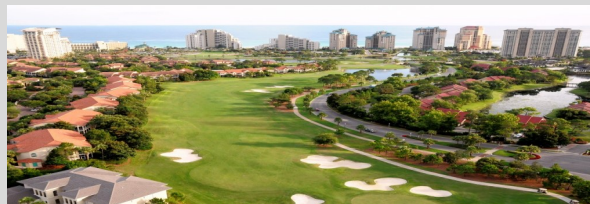
