Honorable Paul W. Bonapfel - Bankruptcy Judge, Northern District of Georgia Paul W. Bonapfel has been a Bankruptcy Judge for the Northern District of Georgia since 2002. Judge Bonapfel graduated *cum laude* from Florida State University and *magna cum laude* from the University of Georgia School of Law. After serving as a judicial law clerk for U.S. District Judge Wilbur D. Owens, Jr., in the Middle District of Georgia, he practiced bankruptcy law in Atlanta for 25 years. Judge Bonapfel is a fellow of the American College of Bankruptcy and a co-author of *Chapter 13 Practice and Procedure* (Thomson Reuters).

Honorable Bess M. Parrish Creswell - Chief Bankruptcy Judge, Middle District of Alabama Bess M. Parrish Creswell was appointed to the U.S. Bankruptcy Court for the Middle District of Alabama in April 2018. Judge Creswell received her B.A. and MBA from Campbell University and her J.D. from Wake Forest University School of Law. Judge Creswell served as law clerk for Judge Ray C. Mullins, U.S. Bankruptcy Court, Northern District of Georgia. She was in private practice from 2005 until her appointment to the bench.
