## **Honorable Keith M. Lundin Bankruptcy Judge (Retired) Middle District of Tennessee**

Keith M. Lundin received his undergraduate degree from Brown University and his J.D. degree from Vanderbilt University Law School. He served as a law clerk to Chief Judge Harry Phillips of the U.S. Court of Appeals for the Sixth Circuit. Prior to his 1982 appointment to the bench, Judge Lundin served as the Chapter 13 Trustee for the Middle District of Tennessee. Judge Lundin retired on June 16, 2016.

## **Yesha Yadav Milton R. Underwood Chair and Professor of Law Robert Belton Director of Diversity, Equity & Community Faculty Co-Director, LL.M. Program Vanderbilt University Law School**

Yesha Yadav received her master's degree from the University of Cambridge in 2003. After being admitted to the bar of England and Wales, she joined the practice of Clifford Chance. She left the practice in 2008 to earn a LL.M. at Harvard Law School. Professor Yadav joined the World Bank in Washington, D.C. in 2009 as legal counsel in the organization's Insolvency and Creditor-Debtor Initiative. She joined Vanderbilt's faculty in 2011.
