According to Commerce Secretary Raimondo, export controls are at the "red-hot center" of how we protect democracies. Deputy Attorney General Monaco has been quoted as saying that sanctions and export enforcement is "the new FCPA." This panel is composed of key representatives from Treasury, Commerce, Justice, and Homeland Security together with private practitioners. The panel will address the initiatives being undertaken by the Biden administration to meet this increasingly important national security and corporate enforcement priority – the prevention of improper financial transactions and the unapproved export of sensitive U.S. technology and goods. Finally, speakers will address the future of sanctions and export enforcement for 2024 and beyond.

This panel will discuss 1) an overview of environmental criminal provisions; 2) explain what distinguishes these prosecutions from many other crimes, including: a lenient scienter requirement; how motive and environmental harm can present challenges to prosecutors and advantages to the defense; use of experts in addressing often hypertechnical proof issues; 3) the fine line between civil and criminal violations of environmental laws; 4) defense and sentencing strategies, including *voir dire*, sentencing guidelines, use of parallel proceedings to help defense; and 5) viewpoints of prosecutors, defense attorneys and criminal investigators on environmental crimes cases.
