ewsom, 37, has achieved more in his young legal career than many attorneys will achieve in their lifetimes. The partner and chair of the appellate litigation group at Bradley Arant Boult Cummings LLP has served as Alabama's solicitor general and has won cases in the U.S. Supreme Court.
