

### I. Certificate of Need Program

- A. AL2018-008, Eastchase Operations, LLC d/b/a The Crossings at Eastchase, Montgomery, AL:** Proposes to construct and operate thirty-two (32) Specialty Care Assisted Living Facility (“SCALF”) beds as part of a senior housing community to be constructed in the Eastchase development in east Montgomery. **Opposition: A letter of objection was filed by the Angels for the Elderly Specialty Care Assisted Living Facility along with a Request to Speak in Opposition.**

Approved.

- B. AL2018-009, River Region ALF, LLC d/b/a River Region at Pike Road a/k/a Vantage Pointe Pike Road, Montgomery County, AL:** Proposes to add thirty-two (32) specialty care assisted living facility beds in a multi-level senior living community in the town of Pike Road, Montgomery County, Alabama. **Opposition: A letter of objection was filed by the Angels for the Elderly Specialty Care Assisted Living Facility along with a Request to Speak in Opposition.**

- C. AL2018-011, Affinity Hospital, LLC d/b/a Grandview Medical Center, Birmingham, AL:** Proposes to add thirty (30) acute care beds pursuant to the State Health Plan section 410-2-4-.02(5) Bed Availability Assurance for Acute Care Hospitals. **Opposition: None.**

- D. AL2018-012, Trego Dialysis, LLC d/b/a Mobile Bay Dialysis, Mobile, AL:** Proposes to establish a new thirteen (13) station ESRD facility consisting of ten (10) new in-center hemodialysis stations, one (1) hemodialysis isolation station and two (2) home training stations, to be used alternatively for home hemodialysis and home peritoneal dialysis. **Opposition: Bio-Medical Applications of Alabama, Inc. filed Notice of Withdrawal of Intervention and Opposition April 10, 2018.**

- E. AL2018-014, Russell Medical Center, Alexander City, AL:** Proposes to establish a swing bed program by certifying ten (10) acute care beds to swing beds. **Opposition: USA Healthcare-Adams, LLC d/b/a Adams Nursing Home, Brown Nursing Home, LLC, Chapman Healthcare Center, Inc., and Dadeville Healthcare Center, LLC, filed a Statement of Opposition and Intervention. A letter from the Alabama Nursing Home Association was filed in opposition to the project.**
