

### I. Certificate of Need Program

- A. AL2019-030, Lakeshore Senior Living, LLC, Guntersville, AL:** Proposes to establish a thirty-two (32) bed specialty care assisted living facility. **Opposition: None.**

- B. AL 2020-002, The Haven Memory Care Facility, Gulf Shores, AL:** Proposes to add eleven (11) specialty care assisted living beds to the existing forty-three (43) bed specialty care assisted living facility, based on the 2018 Statistical Update. **Opposition: ZEJ Spanish Fort Holdings, LLC, d/b/a Spanish Fort OpCo, LLC, filed intervention/opposition and request for oral presentation.**
