CON Review Board Meeting May 18, 2022

- I. Certificate of Need Program
- A. AL2022-012, St. Vincent's East, Birmingham, AL: Proposes to build out of existing shelled space on the seventh (7th) floor of the north tower within its existing hospital for the creation of a dedicated inpatient cardiology unit. Opposition: None.

Approved.

B. AL2022-013, Restore Therapy Services, Ltd., Clanton, AL: Proposes to expand an existing single-specialty outpatient rehabilitation facility in Clanton, Chilton County, Alabama, that currently offers physical therapy services through the addition of speech and occupational therapies. Opposition: None.

- II. Reviewability Determinations and Pending Reviewability Determinations
- A. Reviewability Determinations:

**RV2022-016, IOP Services, LLC,** proposes to establish an intensive outpatient mental health counseling facility by a licensed physician's medical practice. **Status: Non-Reviewable.** 

**RV2022-019, Children's Hospital of Alabama,** proposes to expand the Emergency Department to include the addition of sixteen (16) Emergency Department exam rooms. **Status: Non-Reviewable.** 

**B.** Pending Reviewability Determinations:

**RV2021-019, The Heart Center Cardiology,** proposes to establish an office-based lab pursuant to Ala. Admin. r. 410-1-7-.02 in order to perform low-risk peripheral angiography and interventional procedures and fixed-base diagnostic coronary angiography procedures within a private practice. **(Opposition filed 6/23/2021 by EAMC) Status: Pending.** 

**RV2022-012, Dr. Jason Beaver,** proposes to add percutaneous dialysis maintenance procedures to the menu of services provided in the physician's office. **Status: Pending.** 

RV2022-020, Department of Radiology of the University of South Alabama School of Medicine, proposes to open a radiology physician practice location, including diagnostic services, in Fairhope, Alabama. Status: Pending.

**RV2022-021, Thomas Hospital ASC,** proposes to renovate within existing space to include one (1) additional procedure room and two (2) more pre-op and post-op patient bays in Baldwin County, Alabama. **Status: Pending.**

Annual Report for Hospitals and Related Facilities and Skilled Nursing Facilities Rule Changes: The comment period ended May 5, 2022, for the following rule changes: the amendment of the Annual Report for Hospitals and Related Facilities and the Annual Report for Skilled Nursing Facilities to collect data on inpatient rehabilitation discharges pursuant to the requirements of Ala. Admin. Code r. 410-2-4-.08 (6); and to modify identifying page numbers throughout the Appendix section due to the additional pages added to the reporting forms.
