FREEING A MAN WHO SPENT OVER A DECADE ON DEATH ROW

Lindsey Boney, Dylan Black and Brooks Proctor, helped to exonerate Clemente Aguirre, formerly an inmate on Florida's death row. Mr. Aguirre was convicted and sentenced to death in 2006 for two murders he did not commit. After an unsuccessful direct appeal, he sought a new trial based on newly discovered DNA and confession evidence that pointed to an alternative suspect. After an unsuccessful appeal, a retrial that resulted in a mistrial, and reassignment of the case to a new judge, the retrial commenced again in October 2018. The second retrial lasted three weeks but ended with the state entering a nolle prosequi on all charges. Mr. Aguirre was immediately released and is now a free man. The firm contributed a total of 10,241 pro bono hours to fight to exonerate Mr. Aguirre, with 5,295 hours dedicated to the case in 2018 alone.

PARTNERING TO PROTECT WOMEN FROM ABUSE

Jennifer Commander, an associate in **Birmingham**, represented a client seeking protection from a physically abusive former domestic partner. Jennifer represented the client at two different family court appearances and accompanied her to a criminal hearing, ultimately securing a permanent protection from abuse order. Jennifer accepted the matter as part of Bradley's partnership with the YWCA of Birmingham to provide pro bono legal services to low-income individuals seeking year-long protection from abuse orders.

In the spring of 2018, Bradley began a partnership with Bank of America's legal department to provide pro bono legal services to individuals seeking to obtain year-long domestic violence protection orders. Safe Alliance and Legal Aid of North Carolina are also project partners. **Bridget Warren**, an associate in **Charlotte**, along with an attorney from the legal department of Bank of America, represented



a woman who had been a victim of domestic violence at the hands of a former boyfriend and the father of her child. After a difficult cross-examination in which the client was asked to recount the abuse she had suffered, the judge granted the plaintiff's motion and ordered the defendant not to contact her for one year.

JOINING FORCES TO SERVE CLIENTS IN NEED

Bradley's **Birmingham** office began a corporate partnership in the fall of 2018 with the legal department of Encompass Health to provide free legal services to low-income residents of the Woodlawn neighborhood. Attorneys from Bradley and Encompass Health staff a monthly Help Desk and provide legal advice, make referrals to nonprofit legal organizations and social services, and accept cases for extended representation. The Woodlawn Foundation and Volunteer Lawyers Birmingham are also project partners.

Bradley's **Jackson** office joined the legal department of Entergy Mississippi in hosting a family law legal clinic for clients of the Mississippi Volunteer Lawyers Project. Bradley and attorneys from Entergy Mississippi provided legal counsel, made referrals and accepted cases for extended representation at the clinic. Entergy Mississippi and Bradley expect to partner on new pro bono initiatives in the future.

SUPPORTING VETERANS WITH LEGAL NEEDS

The Veteran's Administration (VA) recently began urging veterans suffering from a wide range of conditions to appoint someone to receive their benefits checks and legal notices in case of their incapacity. If veterans agree, the VA finds them incompetent to handle their own affairs and sends their names to the FBI's National Criminal Information Systems (NCIS) where they are listed as prohibited from possessing firearms — something that can be distressing and potentially threatening to a veteran's future job prospects and personal self-esteem. **Eliot Peace**, an associate in **Tampa**, got the Veteran's Administration (VA) to reverse an incompetence finding that helped his veteran client get his NCIS listing removed and his Second Amendment rights restored. He was also asked to prepare a manual that is now being distributed to help other pro bono lawyers taking on similar VA appeals.

In partnership with the Legal Aid Society of Middle Tennessee and the Cumberlands and Operation Stand Down Tennessee (OSDTN), 12 attorneys in **Nashville** provided legal advice to military veterans. OSDTN is a nonprofit organization that focuses on engaging, equipping and empowering veterans and their families. Bradley attorneys met with veterans to provide legal advice and referrals to legal and social service agencies.

ADVISING NONPROFITS AND BUSINESS OWNERS ON COMPLIANCE ISSUES

Several attorneys in the **Huntsville** office frequently counsel clients of The Catalyst Center for Business & Entrepreneurship, a nonprofit formed to assist small businesses and individuals interested in starting small businesses. Attorneys meet with clients to advise and educate them on topics such as business entity formation, intellectual property protection, and contracts needed to protect small businesses. **Frank Caprio**, managing partner of the Huntsville office, took the lead on connecting our attorneys with clients.

DEFENDING AGAINST WRONGFUL ARRESTS

Attorneys in Bradley's **Huntsville** office represented the interests of federal criminal defendants in several pro bono matters. Bradley's efforts included counseling a federal prisoner through his collateral attack on a 15-year mandatory minimum sentence in the United States Court of Appeals for the Sixth Circuit and drafting an amicus brief on behalf of the National Association for Public Defense in support of certiorari before the United States Supreme Court on a critical Fourth Amendment issue.

SUPPORTING RESIDENTS IN RECOVERY

Helping Up Mission is a nonprofit organization focused on providing hope to people experiencing homelessness, poverty or addiction by meeting their physical, psychological, social and spiritual needs. Attorneys in the **Washington, D.C.** office regularly provide pro bono legal services to clients of Helping Up Mission in the areas of expungement, benefit requisition and license restoration, among others.

PROVIDING PRO BONO DISASTER RELIEF SERVICES

Attorneys in Bradley's **Houston** office continue to serve pro bono clients in the aftermath of 2017's Hurricane Harvey, a hurricane tied with 2005's Hurricane Katrina as the costliest tropical cyclone on record. Bradley attorneys have assisted a number of clients with hurricane-related insurance claims.
